**Cost includes:** 2 days of instruction, lunch, all course materials, NCSLA staff support throughout the preceptorship, and review and submission of all required training documentation.

## Steps on How the 120-hour Program Works

- Visit the website of the NC Division of Health Service Regulation (DHRS) for details on the certification requirements: <https://www2.ncdhhs.gov/dhhr/acls/adminguidelines.html>
- Register for the NCSLA AIT two-day course (16 hours) of classroom instruction, taught by assisted living professionals who provide an overview of laws, rules, policies and procedures.
- In the NCSLA AIT course, you will receive instruction and course materials on rules and regulations, personnel, regulatory management, PCS services, resident care management, nutrition and food service, and environmental and housekeeping.
- Course payment is due in full in advance of the course date (received one week prior) and is **non-refundable**.
- A minimum of 100 hours will be spent working with an approved Preceptor at a licensed facility. There is a self-study portion with work assignments to be completed. Additional hours can be required if determined by the AIT provider and Preceptor. It is highly encouraged that the AIT identify a Preceptor of choice prior to attending the classroom training.

**It is recommended that the AIT preceptorship and program be completed within 6 months of taking the class.**

## Overview on How to Get Started

**Submit the following to:** NC Division of Health Service Regulation (DHRS)

- Assisted Living Certification Application
- Proof of Age—21 years or older (i.e., driver's license)
- Copy of college transcript (Adult Care Home Certification) OR
- High School Diploma or GED (Family Care Home Approval)
- NC state fingerprint criminal background check
- FBI criminal background check, if applicable
- Completion of the 120-hour AIT course and preceptorship
- Administrator Rules Exam

**The certification application, education or supervisory experience documentation and fingerprint checks should be submitted directly to DHRS. Upon completion of the course and preceptorship, a certificate of AIT training completion will be issued by NCSLA. DHRS will issue the Administrator Certification.**
